We are delighted to again this year be able to encourage and support ministry within our Presbytery through the Mission Partnership Grant process. Enclosed in this packet is information that will help you. Review the mission funding values and priorities and tailor your application accordingly.

The Mission Partnership Grants are intended to provide:

- Basic financial support to assist congregations in their ministry; ordinarily these funds are not intended for salary support.
- Mission project support to assist congregations in carrying out specific ministry projects or new outreach efforts.

Guidelines for Mission Partnership Funding Grants:

- All grants are considered annually with no expectation of carry over.
- How have past recipients used their grant to meet goals?
- Are there other or better resources, ie Innovation grants, loans?
- Fund a few grants adequately.

Dates:

- June 10: Applications will be made available at the June Presbytery meeting and will be sent to ministry leaders not present at this June meeting.
- July 31: Applications are due to Candice Wyckoff, Presbytery Executive Assistant, at the presbytery office.
